2. Pastor's Report (Fr. Paul)

Fr. Paul reported that he received a final quotation on the school sign. A school parent volunteered time to put up the sign to help save cost. Total financial cost is \$800. School will pay \$300 and Parish will pay \$500. Parent volunteer will get PP hours.

3. Chairperson's Report (Deborah Harms)

Guardian Angel Committee

- Mike Garisto from the parish is putting together a committee to look at the Guardian Angel Fund.
- Goal is to put together policy/procedure/application package for families seeking assistance and PEC member would assist and appoint member
- Discussion about assigning this position to a PEC role so that it is consistent moving forward
- Decision to tie the role to the Vice Chair position Francine will represent the PEC on the committee

4. Principal's Report (Clive Heah)

- Great start to the new year. We still have 13 students that are on the Temporary Transition Plan. There is no current end date for the transition plan CISVA will determine this.
- Virtual Open House is complete and will be posted on the school website on the homepage.
- Survey was sent home to find out how many siblings will be in Kindergarten next year.
 Preschool teachers also sent out a survey to get numbers of preschoolers coming into Kindergarten. Potential for 37 new kindergarten children next year. Goal to move towards two classes and that will replace the two outgoing grade 7 classes.

<u>Intake Interviews</u> – all new kindergarten students will be interviewed by Clive and Pam in order to assess needs and placement. Only new families to the school will be interviewed by Fr. Paul and Deborah.

<u>Registration and Enrolment</u> – online registration is a go this year. There will be no paper registrations.

<u>School Security</u> – discussion about increasing alarm panel codes in the school versus moving to a fob system in the school. Need to re-key the exterior doors.

Motion by Francine to proceed with the fob system. Mike seconds the motion. Decision to proceed with installing the fob system. Clive to proceed with choosing the supplier.

Christmas concert video was sent out - big thank you to Linsay Castel for her hours of work on this project

CCS will start intermediate spelling bee and readers are leaders program

Student counsel will have a private meeting with Archbishop Miller in February via Zoom to share with him what is happening at CCS.

5. LRD Report – (Pam Paraiso)

IEPs and school based team meetings are on track in the LRD department

8. Parent Participation Report (Michelle Williamson)

Hours completed to date

- 87 families have entered hours in On Volunteer to present
- Of the 87 families, 44 have entered under 10 hours
- 22 families have entered over 20 hours
- 12 families have entered over 25
- 8 families have completed hours
- There is still a lot of interest by families wanting to sign up for hours, but are unable to because the projects have been gone
- Clive to reach out to teachers to encourage them to reach out to parents to provide classroom tasks
- Michelle will send a message to all parents a) asking parents to enter hours because we are reviewing hour requirements, b) if sign up, you need to do the job so not to deprive others an opportunity, c) if you are doing an ad hoc job, please enter your hours as quickly as possible, d) we will be removing the mandatory maintenance hours, e) in February we will be reviewing the hour requirements for the remainder of the year
